## Writing Standards

*The student will...*

### Text Types and Purposes

W.4.1 – Write opinion pieces on topics or texts, supporting a point of view with reasons and information.

- a) Introduce the topic or text clearly, state an opinion, and create an organizational structure in which related ideas are grouped to support the writer's purpose.
- b) Provide reasons that are supported by facts and details.
- c) Link opinion and reasons using words and phrases (e.g., *for instance, in order to, in addition*).
- d) Provide a concluding statement or section related to the opinion presented.

W.4.2 – Write Informative/explanatory texts to examine a topic and convey ideas and information clearly.

- e) Introduce a topic and group related information in paragraphs and sections, include formatting e.g., headings), illustrations, and multimedia when useful to aiding comprehension.
- f) Develop the topic with facts, definitions, concrete details, quotations, or other information and examples related to the topic.
- g) Link ideas within categories of information using words and phrases (e.g., *another, for example, also, because*).
- h) Use precise language and domain-specific vocabulary to inform about or explain the topic.
- i) Provide a concluding statement or section related to the information or explanation presented.

W.4.3 – Write narratives to develop real or imagined experiences or events using effective technique, descriptive details, and clear event sequences.

- j) Orient the reader by establishing a situation and introducing a narrator and/or characters; organize an event sequence that unfolds naturally.
- k) Use dialogue and description to develop experiences and events or show the responses of characters to situations.
- l) Use a variety of transitional words and phrases to manage the sequence of events.
- m) Use concrete words and phrases and sensory details to convey experiences and events precisely.
- n) Provide a conclusion that follows from the narrated experiences or events.

### Production and Distribution of Writing

W.4.4 – Produce clear and coherent writing in which the development and organization are appropriate to task, purpose, and audience. (Grade-specific expectations for writing types are defined in standards 1-3 above.)

**Range of Writing**

## Language Standards

### Conventions of Standard English

- o) Use relative pronouns (*who, whose, whom, which, that*) and relative adverbs (*where, when, why*).
- p) Form and use the progressive (e.g., I was walking; I am walking; I will be walking) verb tenses.
- q) Use modal auxiliaries (e.g., can, may, must) to convey various conditions.
- r) Order adjectives within sentences according to conventional patterns (e.g., a small red bag rather than a red small bag).
- s) Form and use prepositional phrases.
- t) Produce complete sentences, recognizing and correcting inappropriate fragments and run-ons.\*
- u) Correctly use frequently confused words (e.g., to, too, two; there, their).\*

- v) Use correct capitalization.
- w) Use commas and quotation marks to mark direct speech and quotations from a text.
- x) Use a comma before a coordinating conjunction in a compound sentence.

- ff) Explain the meaning of simple similes and metaphors (e.g., *as pretty as a picture*) in context.



hh) Demonstrate understanding of words by relating them to their opposites (antonyms) and to words with similar but not identical meanings (synonyms).

### Comprehension and Collaboration

SL.4.1 – Engage effectively in a range of collaborative discussions (one-on-one, in groups, and teacher-led) with diverse partners on *grade 4 topics and texts*, building on others' ideas and expressing their own clearly.

- ii) Come to discussions prepared, having read or studied required material; explicitly draw on that preparation and other information known about the topic to explore ideas under discussion.
